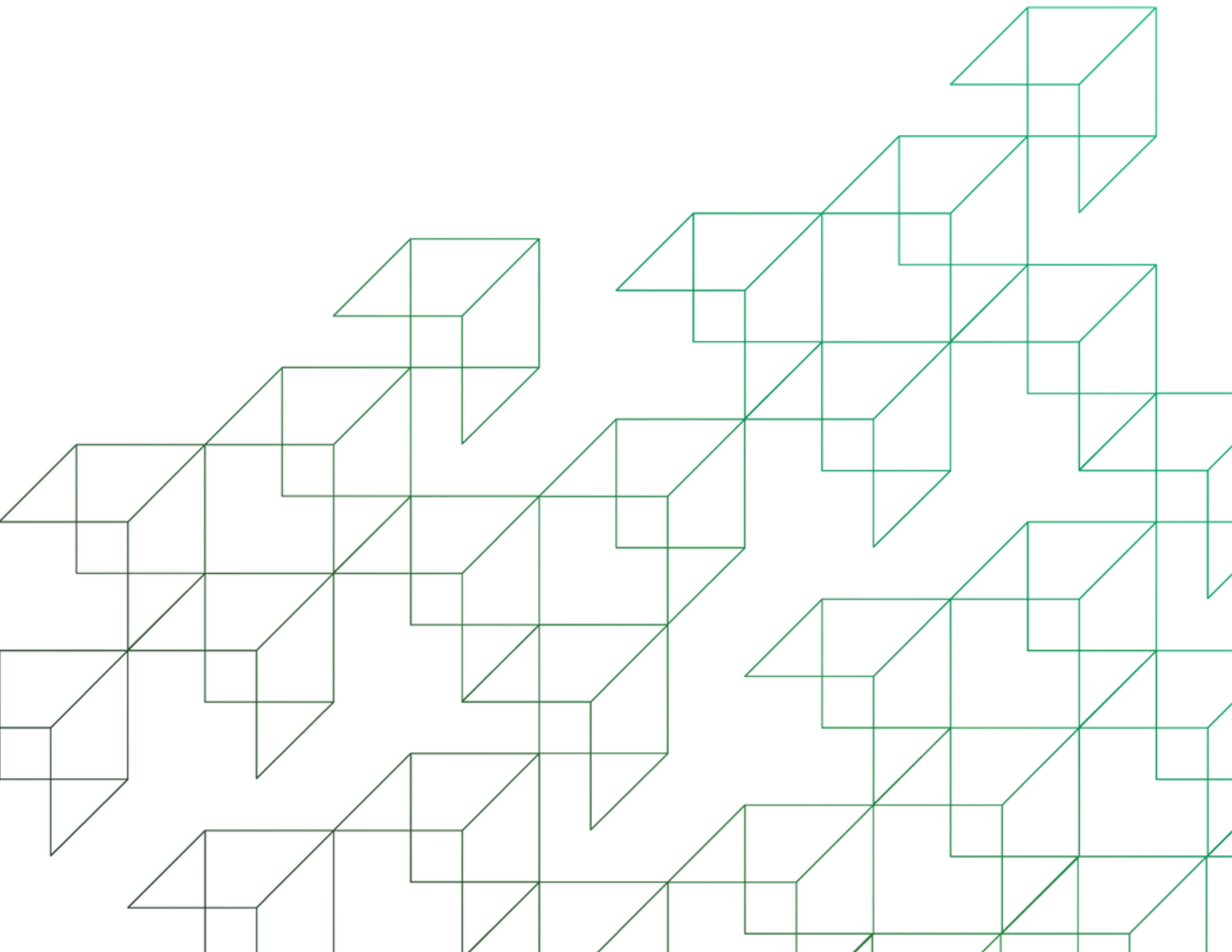
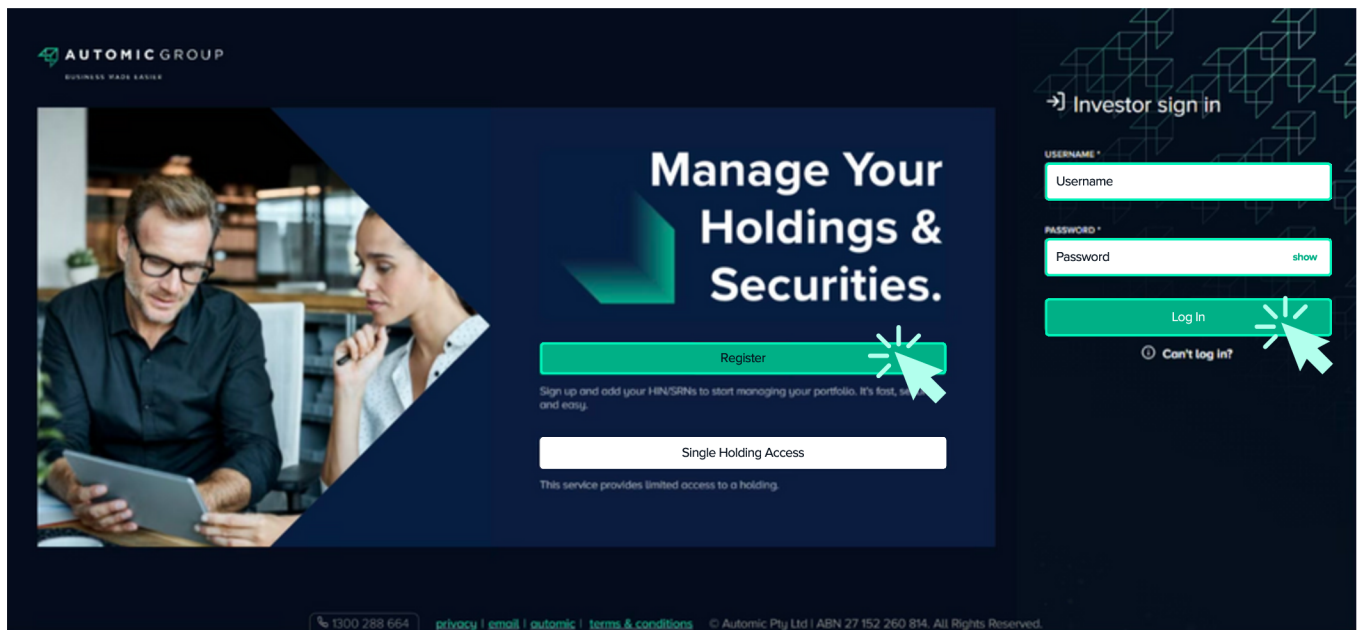


Virtual Meeting Registration and Voting
